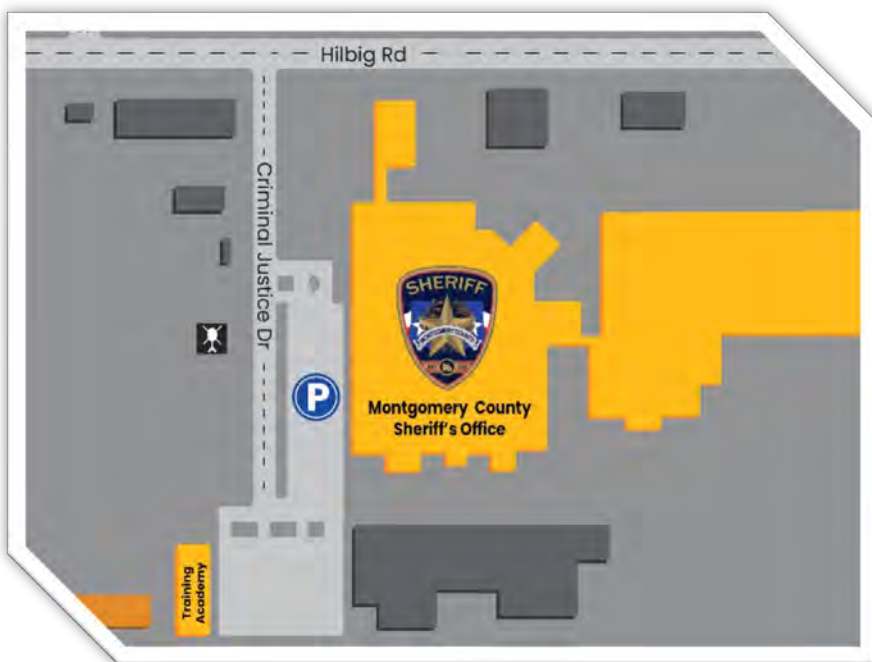


Parking Instructions:

Enter through the front doors, proceed straight down the hall and enter the first classroom on the left.
